- <u>UR Campus Plan</u> Listening Session facilitated by Ayers Saint Gross consultants. Attendees were divided into two break-out sessions, so this part of the meeting could not be recorded.
- Recruitment of USAC representatives for the 2024-25 year will start next month. Please nominate yourself or a colleague.
- Budget Report: \$3, 097.87
- Committee Reports: Benefits Committee, no report. Planning and Priority Committee: Ashley Kuemmerle sent a written report that said lot of thought went into employee raises. Volunteer Committee: Kirstin Stacia thanked everyone who volunteered with Spider Dash. Plant Involvement Team (John Shines submitted in writing): issues with uniform orders; steam plant undergoing restoration; facilities warehouse will hold silent auction for employees only. Faculty Senate, Carole Yeatts: Faculty Senate had presentation by Admissions and Enrollment. UR received over 16,000 applications for incoming first-year class. In wake of Supreme Court ruling, Admissions is now race blind. Supreme Court ruling changed what Admissions can ask on applications. Admissions still has diversity goals, but reaching those goals is trickier now. Described it like following the speed limit when you don't have a speedometer.
